### **Taxes and Legislation**

New York's strength in small business stems from its unique traits, such as its multicultural makeup, large population, and status as a global financial hub. The city hosts headquarters for many of the world's largest banks, investment firms, and multinational corporations. This concentration of high-paying industries increases costs across industries. NYC businesses face high overall tax burdens compared to other locations; they contribute approximately one-third of New York State's total tax revenue.

According to taxfoundation.org, "New York has a graduated state individual income tax, with rates ranging from 4.00% to 10.90%. Some jurisdictions also collect local income taxes. The state corporate income tax ranges from 6.5% to 7.25%. The state sales tax rate is 4.00%, with an average combined state and local sales tax rate of 8.53%. Additionally, the effective property tax rate on owner-occupied housing is 1.54%." High taxes significantly impact the profitability of small businesses, often serving as a barrier to growth.

# **Regulatory Challenges**

Regulatory hurdles—such as strict zoning laws and complex permit processes—also hinder small business success. NYC's zoning laws regulate land use, specifying how land and buildings can be used, which impacts where businesses can operate. Zoning is divided into residential, commercial, and manufacturing zones with specific rules depending on density and purpose. Compliance can be both complex and costly, requiring detailed plans, variances, and lengthy approval processes. These laws influence where commercial hubs develop and can limit growth in certain areas.

For example, restaurant and bar owners often encounter difficulties obtaining permits, such as liquor licenses regulated by the New York State Liquor Authority (SLA). The process involves multiple steps, which may delay business opening and increase costs.

#### **Penalties**

Many small businesses face penalties for non-compliance with environmental, safety, or municipal regulations—sometimes unknowingly. Penalties for tax violations can be substantial. For late tax filing, penalties include 5% of the tax owed per month, up to 25%, with a minimum of \$100 if more than two months late. For late payments, the penalty is 0.5% of unpaid taxes monthly, also capped at 25%. Errors exceeding a 10% difference or \$2,000 can result in a 10% penalty. Penalties for

negligence, fraud, or frivolous filing can be even more severe, including fines up to \$5,000. Underpayments accrue interest, compounded daily, at rates adjusted quarterly.

## **Congestion Pricing and Tariffs**

Recent legislation from both city and federal levels has significantly impacted small businesses. In NYC, congestion pricing was enacted in 2019 and implemented on January 5, 2025, to reduce traffic congestion and improve air quality. However, this measure increases transportation costs for businesses reliant on delivery and logistics, potentially reducing foot traffic in affected areas and hurting retail and service sectors.

At the federal level, tariffs imposed during the Trump administration aimed to address trade deficits but increased costs on imported goods. These tariffs raise prices on consumer electronics, clothing, and raw materials, squeezing profit margins and raising operational costs. Many small businesses sourcing inputs from countries like China face uncertainties about supply chain costs, vendor options, and pricing strategies, all of which can threaten their viability.

# The Importance of Small Businesses to NYC

# **Employment**

According to the NYCEDC, small businesses with fewer than 50 employees contributed to 45% of NYC's employment growth in early 2024 and generated over \$3.2 billion in economic output since early 2022.

### **Revenue and Tax Generation**

Small businesses contribute substantially to the city's tax base through sales, property, and income taxes, supporting city infrastructure and public services.

### **Community Impact**

These businesses strengthen local communities by offering personalized services, promoting neighborhood cultures, and fostering identities unique to each area.
